Vendors must have a business license in their home county/city, State of California resale permit, and general liability and related insurance sufficient to cover their activities. Insurance certificates naming the Byway Association & County of Alpine as additional insureds must be provided prior to the event. Vendors are expected to be set up in their designated space by 11am and must remain until 6pm.

Vendors are expected to provide all staffing, materials & equipment necessary, including, but not limited to, shade covers, tables, chairs, water, cleaning supplies, and garbage receptacles if needed. Electricity is not available, cell coverage can be spotty, and gas generators are discouraged; contact us if you require electricity and we'll see what we can do.
